**Subject: - Mahatma Gandhi National Rural Employment Guarantee Act (Mahatma Gandhi NREGA): Payment of 1<sup>st</sup> Installment of 1<sup>st</sup> tranche of Central Assistance towards wage payment for Financial Year 2024-25 to the State Government of Mizoram.**

I am directed to convey the sanction of the President of India for release of an amount of **Rs. 7,12,64,326/- (Rupees Seven Crore Twelve Lakh Sixty Four Thousand Three Hundred and Twenty Six Only)** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of State/UT of Mizoram as 1<sup>st</sup> Installment of 1<sup>st</sup> tranche out of the sanctioned amount of **Rs. 234,90,11,000/- (Rupees Two Hundred and Thirty Four Crore Ninety Lakh Eleven Thousand Only)** vide Mother sanction order No. J- 11060/23/2024-RE-VI, Sl. No.16 dated 06/04/2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

The payment under DBT are linked to the FTOs generated based on primary records retained at GP/Block level and therefore the accounts/primary records will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development in terms of Rule 236(1) of the General Financial Rules 2017.

4. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.

5. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.

6. All other terms and conditions mentioned in Mother Sanction Order J- 11060/23/2024-RE-VI, Sl. No.16, dated 06/04/2024 shall remain the same.

7. No Utilization Certificate is pending against the Recipient Organization under the Scheme.

8. The account of grantee institutions will be audit by the Comptroller and Auditor General of India and the Internal Audit of the Principal Account Office of the Ministry in terms of **Rule 236(1) of the General Financial Rules, 2017**

9. The DDO, MGNREGA, New Delhi (207172), Ministry of Rural Development will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para –1 above will be transferred to State Employment Guarantee Fund in Account No.37260626185 in the name of NeFMS SEGF (Mahatma Gandhi NREGA), Mizoram, State Bank of India, New Secretariat Branch, New Secretariat Complex, Aizawl and IFSC SBIN0013053.

10. This issue under the powers delegated to this Ministry and in consultation with the Integrated Finance Division vide their **U.O. No. 18/Finance/2024-25, dated 05/04/2024.**

11. Keeping in view the imposition of model code of conduct in the light of General Election of 2024, the sanction is subject to following condition:

- Absolutely no publicity in this regard shall be made in electronic, print, radio and internet or any other media, in any form whatsoever.
- No political functionary shall make any reference in this regard during any public speech or communication to the press or public.
- These restrictions on publicity will be applicable on both i.e. Central Government as well as the State Government.
- The relevant provisions of Model Code of Conduct issued by the Election Commission shall be strictly followed.
