Subject- Mahatma Gandhi National Rural Employment Guarantee Act (Mahatma Gandhi NREGA) - on account of payment of 1st installment of 2nd tranche of Central Assistance for financial year 2024-25 to the State Government of Jharkhand.

Sir,

I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to **Rs.21,86,84,000/- (Rupees Twenty One Crore Eighty Six Lakh and Eighty Four Thousand Only)** towards Admin component only to State Govt. of Jharkhand as Central assistance for payment of Administrative Component through National Rural Employment Guarantee Act (Mahatma Gandhi NREGA) during the FY 2024-25.

2. The Pending liabilities (Administrative Component) must be cleared keeping in view the period of pendency. The old pending liabilities should be cleared first. The Status of clearance of old pending liabilities will be reviewed by the Ministry from time to time.

3. The above amount will be released in installments on daily basis, based on FTOs generated by State as per actual expenditure and as captures by Mahatma Gandhi NREGASoft & PFMS.

- 4. Further the following conditions shall be fulfilled in utilisation of these funds:
  - a) Adherence to the time line indicated in the minutes of the Labour Budget Meeting of FY 2024-25 against various key activities.
  - b) In all Electronic Fund Management system (eFMS) 'implemented' areas, the funds shall be maintained at the State level; and there shall be no intermediary accounts. All payments in these areas shall move directly from the State fund to the destination accounts based on the pay order generated at the Block/Gram Panchayat level.
  - c) Where eFMS is not yet implemented, steps shall be taken to implement the same at the earliest.
  - d) The detailed voucher-based data shall be available in the NREGASoft for all the expenditure done.
  - e) The material component including wages of skilled and semi-skilled labour shall not exceed 40% at district level.
  - f) The Expenditure of material component including wages of skilled and semi-skilled labour will be shared between Centre and State Government in the ratio of 75:25.
  - g) This grant is towards plan expenditure and shall be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines. No deviation from the provisions of the Guidelines is permissible.
  - h) The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of financial year which shall include interest accrued. Interest accrued should be computed based on the details of ledger account maintained for the purpose.
- 5. No Utilization Certificate is pending against the Recipient Organization under the Scheme.
- 6. Funds towards admin contingency must be used against admin expenses (salary etc.).

7. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 236 (1) of the General Financial Rules 2017.

8. The expenditure incurred out of this sanction is to be processed in accordance with the instructions of Department of Expenditure issued vide O.M. No. 1(27)/PFMS/2020 dated 13<sup>th</sup> July, 2023, dated 7<sup>th</sup> August, 2023, dated 20<sup>th</sup> November, 2023, dated 16<sup>th</sup> January, 2024 and dt. 20<sup>th</sup> June, 2024.
