4. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.

6. All other terms and conditions mentioned in Mother Sanction order No.J-12011/01/2024/RE-VIII (387879)/SL.No.48, dated 21/06/2024 shall remain the same.
