6. All other terms and conditions mentioned in Mother Sanction order **No.J-12011/01/2024/RE-VIII (387879)/Sl.No.48**, dated **21/06/2024** shall remain the same.
7. The DDO, MGNREGA, New Delhi (207172), Ministry of Rural Development will be the Drawing & Disbursing Officer for the purpose.
