



I am directed to convey the sanction of the President of India for release of an amount of Rs.5,41,34,827/- (Rupees Five Crore Forty One Lakh Thirty Four Thousand Eight Hundred and Twenty Seven Only) to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of State of Assam as 4th Installment out of the sanctioned amount of Rs.288,43,50,036/- (Rupees Two Hundred Eighty Eight Crore Forty Three Lakh Fifty Thousand and Thirty Six Only) vide Mother sanction order No.J-12011/01/2024/RE-VIII (387879)/Sl.No.87, dated 25/07/2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

The payment under DBT are linked to the FTOs generated based on primary records retained at GP/Block level and therefore the accounts/primary records will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development in terms of Rule 236(1) of the General Financial Rules 2017.
4. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.
5. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.
6. All other terms and conditions mentioned in Mother Sanction order No.J-12011/01/2024/RE-VIII (387879)/Sl.No.87, dated 25/07/2024 shall remain the same.
7. The DDO, MGNREGA, New Delhi (207172), Ministry of Rural Development will be the Drawing & Disbursing Officer for the purpose.
8. The amount mentioned in Para -1 above will be transferred to the State Govt. Assam in Account No. 35623799200 in the bank State Bank of India, Branch, Dispur and Branch IFSC SBIN0003030.
