

The residual amount of Rs. 100,09,97,417/-[(SC: Rs. 45,31,27,160/-), (ST: Rs. 51,74,99,709/-) and (OTH:Rs.3,03,70,548/-)] vide mother sanction order even no. dated 16.07.2024 (U.O.No.250/Finance/2024-25, dated 12.07.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is Rs. 405,00,00,730/- (NeFMS amount) + Rs. 100,09,97,417/- (residual amount of previous mother sanction) i.e total Rs. 505,09,98,147/-

- The Drawing and Disbursing Officer, Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para-1 above will be transferred to the State Employment Guarantee Fund in Account No. 3568124699 in the name of MP State Employment Guarantee Council Bhopal, in the Central Bank of India, 9 Area Hills Bhopal and Branch IFSC Code CBIN0283312.
