

I am directed to convey the sanction of the President of India for release of an amount of Rs. 4,63,20,841/-(Rupees Four Crore Sixty Three Lakh Twenty Thousand Eight Hundred and Forty One Only) to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of State of Madhya Pradesh as 4th Installment of 1st tranche out of the sanctioned amount of Rs.405,00,00,730/-(Rupees Four Hundred and Five Crore Seven Hundred and Thirty Only) vide Mother sanction order No. J-12011/01/2024-RE-IV SI.No.101 dated 12.08.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

- The residual amount of Rs. 100,09,97,417/-[(SC: Rs. 45,31,27,160/-), (ST: Rs. 51,74,99,709/-) and (OTH:Rs.3,03,70,548/-)] vide mother sanction order even no. dated 16.07.2024 (U.O.No.250/Finance/2024-25, dated 12.07.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is Rs. 405,00,00,730/- (NeFMS amount) + Rs. 100,09,97,417/- (residual amount of previous mother sanction) i.e total Rs. 505,09,98,147 /-

- All other terms and conditions mentioned in Mother Sanction order No.J-12011/01/2024-RE-IV SI.No.101 dated 12.08.2024 shall remain the same.
- No Utilization Certificate is pending against the Recipient Organization under the Scheme.
- The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 236 (1) of the General Financial Rules, 2017.
- The Drawing and Disbursing Officer, Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para-1 above will be transferred to the State Employment Guarantee Fund in Account No. 3568124699 in the name of MP State Employment Guarantee Council Bhopal, in the Central Bank of India, 9 Area Hills Bhopal and Branch IFSC Code
