The residual amount of Rs. 88,76,87,606/-[(SC: Rs. 51,18,73,288/-), (ST: Rs. 37,24,55,097/-) and (OTH: Rs.33,59,221/-)] vide mother sanction order even no. dated 12.08.2024 (U.O.No.356/Finance/2024-25, dated 12.08.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is Rs. 1,165,39,00,000/- (NeFMS amount) + Rs. 88,76,87,606/- (residual amount of previous mother sanction) i.e total Rs. 1254,15,87,606/-

- 8. No Utilization Certificate is pending against the Recipient Organization under the Scheme.
- 9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 236 (1) of the General Financial Rules, 2017.
