- 9. The Drawing and Disbursing Officer, Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para-1 above will be transferred to the State Employment Guarantee Fund in Account No. 3568124699 in the name of MP State Employment Guarantee Council Bhopal, in the Central Bank of India, 9 Area Hills Bhopal and Branch IFSC Code CBIN0283312.
