Hence, the total amount available for release to the State for wages is Rs. 809,98,99,000/- (NeFMS amount) + Rs.10,43,77,114/- (re-initiated amount) + Rs. 76,75,83,896/- (residual amount of previous mother sanction) i.e total Rs. 897,18,60,010/-
