- 2. PAO has reported Rs. 10,43,77,114/- as refunded amount due to the failed transactions during 1st April to 31st May 2024. This amount has also been included in the current mother sanction for utilizing the fund. The residual amount of Rs. 76,75,83,896/-[(SC: Rs. 30,83,20,176/-), (ST: Rs. 44,91,04,579/-) and (OTH:Rs. 1,01,59,141/-)] vide mother sanction order even no. dated 06.04.2024 (U.O.No.16/Finance/2024-25, dated 05.04.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is Rs. 809,98,99,000/- (NeFMS amount) + Rs.10,43,77,114/- (re-initiated amount) + Rs. 76,75,83,896/- (residual amount of previous mother sanction) i.e total Rs. 897,18,60,010/-

- 9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 236 (1) of the General Financial Rules, 2017.
