**Subject:-Mahatma Gandhi National Rural Employment Guarantee Act (Mahatma Gandhi NREGA): Payment of 2<sup>nd</sup> Installment of 1<sup>st</sup> tranche of Central Assistance towards wage payment for Financial Year 2024-25 to the State of Madhya Pradesh.**

I am directed to convey the sanction of the President of India for release of an amount of **Rs. 17,39,35,454/- (Rupees Seventeen Crore Thirty Nine Lakh Thirty Five Thousand Four Hundred and Fifty Four Only)** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of State of Madhya Pradesh as 2<sup>nd</sup> Installment of 1<sup>st</sup> tranche out of the sanctioned amount of **Rs. 809,98,99,000/- (Rupees Eight Hundred Nine Crore Ninety Eight Lakh and Ninety Nine Thousand Only)** vide Mother sanction order No. **J-12011/01/2024-RE-IV Sl.No.47 dated 20.06.2024** for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.


2. PAO has reported **Rs. 10,43,77,114/-** as refunded amount due to the failed transactions during 1<sup>st</sup> April to 31<sup>st</sup> May 2024. This amount has also been included in the current mother sanction for utilizing the fund. The residual amount of **Rs. 76,75,83,896/-** [(SC: **Rs. 30,83,20,176/-**), (ST: **Rs. 44,91,04,579/-**) and (OTH:**Rs. 1,01,59,141/-**)] vide mother sanction order even no. dated 06.04.2024 (U.O.No.16/Finance/2024-25, dated 05.04.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is **Rs. 809,98,99,000/- (NeFMS amount) + Rs.10,43,77,114/- (re-initiated amount) + Rs. 76,75,83,896/- (residual amount of previous mother sanction) i.e total Rs. 897,18,60,010/-**

3. The total amount available for release to the State for wages is **Rs. 390,72,47,549/-** is as under:-

The payment under DBT are linked to the FTOs generated based on primary records retained at GP/Block level and therefore the accounts/primary records will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development in terms of Rule 236(1) of the General Financial Rules 2017.
5. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.
6. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.
7. All other terms and conditions mentioned in Mother Sanction order No.J-12011/01/2024-RE-IV SI.No.47 dated 20.06.2024 shall remain the same.
8. No Utilization Certificate is pending against the Recipient Organization under the Scheme.
9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of **Rule 236 (1) of the General Financial Rules, 2017.**
10. The Drawing and Disbursing Officer, Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para-1 above will be transferred to the State Employment Guarantee Fund in **Account No. 3568124699 in the name of MP State Employment Guarantee Council Bhopal, in the Central Bank of India, 9 Area Hills Bhopal and Branch IFSC Code CBIN0283312.**
11. This issue under the powers delegated to this Ministry and in consultation with the Integrated Finance Division vide their **U.O No. 163/Finance/2024-25, dated 19.06.2024.**


