No. 145 dated 22.11.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

- 2. PAO has reported Rs. 8,90,40,278/- as refunded amount due to the failed transactions during 1st June, 2024 to 31st October, 2024. This amount has also been included in the current Mother Sanction order for utilizing the fund. The residual amount of Rs. 301,48,78,115/-[(SC: Rs. 35,93,60,364/-), (ST: Rs. 79,03,901/-) and (OTH: Rs. 264,76,13,850/-)] vide mother sanction order of even no. dated 08.08.2024 (U.O. Hence, the total amount available for release to the State for wages is Rs.1033,54,31,602/-(NeFMS amount) + Rs. 8,90,40,278/-(re-initiated amount) Rs.301,48,78,115/-(residual amount of previous mother sanction) i.e total Rs. 1343,93,49,995/-
