I am directed to convey the sanction of the President of India for release of an amount of Rs. 11,31,27,722/-(Rupees Eleven Crore Thirty One Lakh Twenty Seven Thousand Seven Hundred and Twenty Two Only) to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of State of Karnataka as 2<sup>nd</sup> Installment of 2<sup>nd</sup> tranche out of the sanctioned amount of Rs.1033,54,31,602/-(Rupees One Thousand Thirty Three Crore Fifty Four Lakh Thirty One Thousand Six Hundred and Two Only) vide Mother sanction order No. J-12012/01/2024-RE-IV Sl. No. 145 dated 22.11.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

- 2. PAO has reported Rs. 8,90,40,278/- as refunded amount due to the failed transactions during 1st June, 2024 to 31st October, 2024. This amount has also been included in the current Mother Sanction order for utilizing the fund.
