- 2. PAO has reported Rs. 3,52,49,527/- as refunded amount due to the failed transactions during 1<sup>st</sup> April, 2024 to 30<sup>th</sup> April, 2024. This amount has also been included in the current Mother Sanction order for utilizing the fund. Hence, the total amount available for release to the State for wages is Rs.756,15,64,000/-(NeFMS amount) + Rs. 3,52,49,527/-(re-initiated amount) + Rs. 190,02,48,725/-(residual amount of previous mother sanction) i.e total Rs. 949,70,62,252/-
