
2. The residual amount of **Rs. 246,20,76,368/-** [(SC: **Rs. 52,70,327/-**), (ST: **Rs.245,68,01,503/-**) and (OTH:**Rs. 4,538/-**)] vide mother sanction order even no. dated 26.07.2024 (U.O.No.306/Finance/2024-25, dated 26.07.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is **Rs. 135,96,91,545/- (NeFMS amount)+ Rs. 246,20,76,368/- (residual amount of previous mother sanction) i.e total Rs. 382,17,67,913/-**

3. The total amount available for release to the State for wages is **Rs. 193,46,48,329/-** is as under:-

5. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.
6. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.
7. All other terms and conditions mentioned in mother sanction order **No. J-12013/01/2024-RE IV Sl. No. 119 dated 13.09.2024** shall remain the same.
8. No Utilization Certificate is pending against the Recipient Organization under the Scheme.
9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of **Rule 236 (1) of the General Financial Rules, 2017**.
10. The Drawing and Disbursing Officer, Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para-1 above will be transferred to State Employment Guarantee Fund in **Account No. 37257908517 in the name of State Employment Guarantee Fund NeFMS, in the State Bank of India (SBI), M.G. Road, Shillong, Meghalaya (Sectt. Branch), IFSC Code: SBIN0006320**.


