- PAO has reported Rs. 1,41,28,133/- as refunded amount due to the failed transactions during 1st June, 2024 to 31st October, 2024. This amount has also been included in the current Mother Sanction order for utilizing the fund. The residual amount of Rs. 24,97,86,688/-[(SC: Rs. 70,979/-), (ST: Rs.22,85,15,745/-) and (OTH:Rs. 2,11,99,964/-)] vide mother sanction order even no. dated 13.09.2024 (U.O.No.480/Finance/2024-25, dated 13.09.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is Rs. 158,62,00,000/- (NeFMS amount) + Rs. 24,97,86,688/- (residual amount of previous mother sanction) + Rs. 1,41,28,133 (Re-initiated amount) i.e total Rs. 185,01,14,821/-
- The total amount of Rs. 172,20,81,743/- is distributed among different categories of beneficiaries as under-
