Hence, the total amount available for release to the State for wages is Rs. 158,62,00,000/- (NeFMS amount) + Rs. 24,97,86,688/- (residual amount of previous mother sanction) + Rs. 1,41,28,133 (Re-initiated amount) i.e total Rs. 185,01,14,821/-
