I am directed to convey the sanction of the President of India for release of an amount Rs. 54,70,144/- (Rupees Fifty Four Lakh Seventy Thousand One Hundred and Forty Four Only) to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of Meghalaya as 1st Installment of 2nd tranche out of the sanctioned amount of Rs. 158,62,00,000/-(Rupees One Hundred Fifty Eight Crore Sixty Two Lakh Only) vide Mother sanction order No. J-12013/01/2024-RE-IV S1.No.162 dated 08.01.2025 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

- 2. PAO has reported Rs. 1,41,28,133/- as refunded amount due to the failed transactions during 1st June, 2024 to 31st October, 2024. This amount has also been included in the current Mother Sanction order for utilizing the fund. The residual amount of Rs. 24,97,86,688/-[(SC: Rs. 70,979/-), (ST: Rs.22,85,15,745/-) and (OTH:Rs. 2,11,99,964/-)] vide mother sanction order even no. dated 13.09.2024 (U.O.No.480/Finance/2024-25, dated 13.09.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is Rs. 158,62,00,000/- (NeFMS amount) + Rs. 24,97,86,688/- (residual amount of previous mother sanction) + Rs. 1,41,28,133 (Re-initiated amount) i.e total Rs. 185,01,14,821/-

- 8. No Utilization Certificate is pending against the Recipient Organization under the Scheme.
- 9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 236 (1) of the General Financial Rules, 2017.
- 10. The Drawing and Disbursing Officer, Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para-1 above will be transferred to State Employment Guarantee Fund in Account No. 37257908517 in the name of State Employment Guarantee Fund NeFMS, in the State Bank of India (SBI), M.G.
