Subject:-Mahatma Gandhi National Rural Employment Guarantee Act (Mahatma Gandhi NREGA): Payment of 2nd Installment of 1st tranche of Central Assistance towards wage payment for Financial Year 2024-25 to the State Government of Meghalaya.

Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs. 1,44,98,394/- (Rupees One Crore Forty Four Lakh Ninety Eight Thousand Three Hundred and Ninety Four Only)** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of Meghalaya as **2nd Installment** of 1st tranche out of the sanctioned amount of **Rs.122,29,53,000/- (Rupees One Hundred Twenty Two Crore Twenty Nine Lakh and Fifty Three Thousand Only)** vide Mother sanction order No. J-12013/01/2024-RE IV Sl.No.31 dated 02.05.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.


2. The residual amount of **Rs. 131,64,74,916/-** [(SC: **Rs. 16,92,203/-**), (ST: **Rs. 131,47,16,593/-**) and (OTH:**Rs. 66,120/-**)] vide mother sanction order even no. dated 06.04.2024 (U.O.No.17/Finance/2024-25, dated 05.04.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is **Rs. 122,29,53,000/- (NeFMS amount) + Rs. 131,64,74,916/- (residual amount of previous mother sanction) i.e total Rs. 253,94,27,916/-**

3. The total amount available for release to the State for wages is **Rs. 246,47,76,808/-** is as under:-

4. The payment under DBT are linked to the FTOs generated based on primary records retained at GP/Block level and therefore the accounts/primary records will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development in terms of Rule 236(1) of the General Financial Rules 2017.
5. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.
6. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.
7. All other terms and conditions mentioned in mother sanction order No. **J-12013/01/2024-RE IV Sl. No.31 dated 02.05.2024** shall remain the same.
8. No Utilization Certificate is pending against the Recipient Organization under the Scheme.
9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of **Rule 236 (1) of the General Financial Rules, 2017**.
10. The Drawing and Disbursing Officer, Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para-1 above will be transferred to State Employment Guarantee Fund in **Account No. 37257908517 in the name of State Employment Guarantee Fund NeFMS, in the State Bank of India (SBI), M.G. Road, Shillong, Meghalaya (Sectt. Branch), IFSC Code: SBIN0006320**.
11. This issue under the powers delegated to this Ministry and in consultation with the Integrated Finance Division vide their **U.O. No. 63/Finance/2024-25 dated 01.05.2024**.
12. Keeping in view the imposition of model code of conduct in the light of General Election of 2024, the sanction is subject to following conditions:
 - i. Absolutely no publicity in this regard shall be made in electronic, print, radio and internet or any other media, in any from whatsoever.
 - ii. No political functionary shall make any reference in this regard during any public speech or communication to the press or public.
 - iii. These restrictions on publicity will be applicable on both i.e. Central Government as well as the State Government.
 - iv. The relevant provisions of Model Code of Conduct issued by the Election Commission shall be strictly followed.


