The residual amount of Rs. 131,64,74,916/-[(SC: Rs. 16,92,203/-), (ST: Rs. 131,47,16,593/-) and (OTH:Rs. 66,120/-)] vide mother sanction order even no. dated 06.04.2024 (U.O.No.17/Finance/2024-25, dated 05.04.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is Rs. 122,29,53,000/- (NeFMS amount) + Rs. 131,64,74,916/- (residual amount of previous mother sanction) i.e total Rs. 253,94,27,916/-

- 4. - 6. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.
- All other terms and conditions mentioned in mother sanction order No. J-12013/01/2024-RE IV Sl. No.31 dated 02.05.2024 shall remain the same.
- No Utilization Certificate is pending against the Recipient Organization under the Scheme.
- 9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 236 (1) of the General Financial Rules, 2017.
- 10. The Drawing and Disbursing Officer, Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para-1 above will be transferred to State Employment Guarantee Fund in Account No. 37257908517 in the name of State Employment Guarantee Fund NeFMS, in the State Bank of India (SBI), M.G. - 12. Keeping in view the imposition of model code of conduct in the light of General Election of 2024, the sanction is subject to following conditions:
- i. Absolutely no publicity in this regard shall be made in electronic, print, radio and internet or any other media, in any from whatsoever.
- ii.No political functionary shall make any reference in this regard during any public speech or communication to the press or public.
- These restrictions on publicity will be applicable on both i.e. Central Government as well as the State Government.
- iv. The relevant provisions of Model Code of Conduct issued by the Election Commission shall be strictly followed.
