The residual amount of Rs. 213,11,09,096/-**(SC: Rs. 70,18,819/-), (ST: Rs. 212,40,16,777/-) and (OTH:Rs. 73,500/-)** vide mother sanction order even no. dated 16.07.2024 (U.O.No.252/Finance/2024-25, dated 12.07.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is Rs. 61,15,28,000/- **(NeFMS amount)+ Rs. 213,11,09,096/- (residual amount of previous mother sanction) i.e total Rs. 274,26,37,096/-**

7. All other terms and conditions mentioned in mother sanction order No. J-12013/01/2024-RE IV Sl. No.92 dated 26.07.2024 shall remain the same.
8. No Utilization Certificate is pending against the Recipient Organization under the Scheme.
9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 236 (1) of the General Financial Rules, 2017.
10. The Drawing and Disbursing Officer, Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para-1 above will be transferred to State Employment Guarantee Fund in Account No. 37257908517 in the name of State Employment Guarantee Fund NeFMS, in the State Bank of India (SBI), M.G. Road, Shillong, Meghalaya (Sectt. Branch), IFSC Code: SBIN0006320.
