Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs. 40,56,933/- Rupees Forty Lakh Fifty Six Thousand Nine Hundred and Thirty Three Only** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of Tripura as 3rd Installment out of the sanctioned amount of **Rs.181,49,00,203/- (Rupees One Crore Fifty Five Lakh Sixty Thousand and Forty Six Only)** vide Mother sanction order No. J-12014/01/2024-RE-IV Sl.No.88 dated 26.07.2024 for implementation of the mahatma Gandhi NREGA during the financial year 2024-25.

2. The residual amount of **Rs. 23,56,43,271/-** [(SC: **Rs. 7,30,10,044/-**), (ST: **Rs. 38,64,724/**) and (OTH: **Rs. 15,87,68,503/-**)] vide mother sanction order of even no. dated 16.07.2024 (U.O. No. 262/Finance/2024-25, dated 12.07.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is **Rs.181,49,00,203/- (NeFMS amount)+Rs. 23,56,43,271/- (residual amount of previous mother sanction) i.e total Rs.205,05,43,474/-**

3. The total amount available for release to the State for wages is **Rs. 95,68,28,710/-** is as under:-

5. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.
6. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.
7. All other terms and conditions mentioned in mother sanction order No. J-12014/01/2024-RE-IV Sl.No.88 dated 26.07.2024 shall remain the same.
8. No Utilization Certificate is pending against the Recipient Organization under the Scheme.
9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 236 (1) of the General Financial Rules, 2017.
10. The Drawing and Disbursing Officer, Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para-1 above will be transferred to State Employment Guarantee Fund in Account No. 35622870026 in the name of State Employment Guarantee Fund Tripura, in the State Bank of India, Branch TLA HOUSE, IFSC Code SBIN0005559.
