**Subject:-Mahatma Gandhi National Rural Employment Guarantee Act (Mahatma Gandhi NREGA) : Payment of 1<sup>st</sup> Installment of 2<sup>nd</sup> tranche of Central Assistance towards wage payment for Financial Year 2024-25 to the State Government of Rajasthan.**

I am directed to convey the sanction of the President of India for release of an amount of **Rs. 16,39,88,339/- Rupees Sixteen Crore Thirty Nine Lakh Eighty Eight Thousand Three Hundred and Thirty Nine Only** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of Rajasthan 1<sup>st</sup> Installment of 2<sup>nd</sup> tranche out of the sanctioned amount of **Rs.1634,15,84,198/- (Rupees One Thousand Six Hundred Thirty Four Crore Fifteen Lakh Eighty Four Thousand One Hundred and Ninety Eight Only)** vide Mother sanction order No J-12015/01/2024-RE-IV Sl. No. 102 dated 22.08.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

2. The residual amount of **Rs. 462,10,99,139/-** [(SC: **Rs. 175,41,40,938/-**), (ST: **Rs. 26,31,868/**) and (OTH: **Rs. 286,43,26,333/-**)] vide mother sanction order of even no. dated 26.07.2024 (U.O. No. 304/Finance/2024-25, dated 26.07.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is **Rs.1634,15,84,198/-**(NeFMS amount) + **Rs. 462,10,99,139/-** (residual amount of previous mother sanction) i.e total **Rs. 2096,26,83,337/-**

3. The total amount available for release to the State for wages is **Rs. 1505,34,21,758/-** is as under:-

5. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.
6. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.
7. All other terms and conditions mentioned in mother sanction order No. J-12015/01/2024-RE-IV Sl. No. 102 dated 22.08.2024 shall remain the same.
8. No Utilization Certificate is pending against the Recipient Organization under the Scheme.
9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 236 (1) of the General Financial Rules, 2017.
10. The Drawing and Disbursing Officer, Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para -1 above will be transferred to State Employment Guarantee Fund in Account No. 61310683569 in the name of State Employment Guarantee Fund Jaipur, in the State Bank of India (SBI), Branch SBI Secretariat Jaipur, IFSC Code: SBIN0031031.


