

- 2. The residual amount of Rs. 95,23,61,831/-[(SC: Rs. 80,75,40,008/-), (ST: Rs. 79,54,767/) and (OTH: Rs. 13,68,67,056/-)] vide mother sanction order of even no. dated 22.08.2024 (U.O. No. 367/Finance/2024-25, dated 21.08.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is Rs. 856,48,00,000/-(NeFMS amount) + Rs. 95,23,61,831/-(residual amount of previous mother sanction) i.e total Rs. 951,71,61,831/-
