2. The residual amount of Rs. 95,23,61,831/-[(SC: Rs. 80,75,40,008/-), (ST: Rs. 79,54,767/) and (OTH: Rs. 13,68,67,056/-)] vide mother sanction order of even no. dated 22.08.2024 (U.O. No. 367/Finance/2024-25, dated 21.08.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds.
