**Subject:-Mahatma Gandhi National Rural Employment Guarantee Act (Mahatma Gandhi NREGA) : Payment of 2<sup>nd</sup> Installment of 1<sup>st</sup> tranche of Central Assistance towards wage payment for Financial Year 2024-25 to the State Government of Rajasthan.**

Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs. 98,75,96,467/- Rupees Ninety Eight Crore Seventy Five Lakh Ninety Six Thousand Four Hundred and Sixty Seven Only** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of Rajasthan 2<sup>nd</sup> Installment of 1<sup>st</sup> tranche out of the sanctioned amount of **Rs. 886,65,65,000/- (Rupees Eight Hundred Eighty Six Crore Sixty Five Lakh and Sixty Five Thousand Only)** vide Mother sanction order No J-12015/01/2024-RE-IV Sl. No. 39 dated 03.06.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

2. PAO has reported **Rs. 56,81,48,560/-** as refunded amount due to the failed transactions during 1<sup>st</sup> April, 2024 to 30<sup>th</sup> April, 2024. This amount has also been included in the current Mother Sanction order for utilizing the fund. The residual amount of **Rs. 153,59,45,527/- (SC: Rs. 82,19,02,248/-), (ST: Rs.2,09,40,278/-) and (OTH: Rs. 69,31,03,001/-)** vide mother sanction order of even no. dated 06.04.2024 (U.O. No. 21/Finance/2024-25, dated 05.04.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is **Rs.886,65,65,000/- (NeFMS amount)+Rs. 56,81,48,560/- (re-initiated amount) + Rs. 153,59,45,527/- (residual amount of previous mother sanction) i.e total Rs. 1097,06,59,087/-**

3. The total amount available for release to the State for wages is **Rs. 1097,06,59,087/-** is as under:-

The payment under DBT are linked to the FTOs generated based on primary records retained at GP/Block level and therefore the accounts/primary records will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development in terms of Rule 236(1) of the General Financial Rules 2017.
5. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.
6. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.
7. All other terms and conditions mentioned in mother sanction order No. J-12015/01/2024-RE-IV Sl. No. 39 dated 03.06.2024 shall remain the same.
8. No Utilization Certificate is pending against the Recipient Organization under the Scheme.
9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 236 (1) of the General Financial Rules, 2017.
10. The Drawing and Disbursing Officer, Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para -1 above will be transferred to State Employment Guarantee Fund in Account No. 61310683569 in the name of State Employment Guarantee Fund Jaipur, in the State Bank of India (SBI), Branch SBI Secretariat Jaipur, IFSC Code: SBIN0031031.
11. This issue under the powers delegated to this Ministry and in consultation with the Integrated Finance Division vide their U.O. No.130/Finance/2024-25 dated 31.05.2024.
12. Keeping in view the imposition of model code of conduct in the light of General Election of 2024, the sanction is subject to following conditions:-
  - (i) Absolutely no publicity in this regard shall be made in electronic, print, radio and internet or any other media, in any from whatsoever.
  - (ii) No political functionary shall make any reference in this regard during any public speech or communication to the press or public.
  - (iii) These restrictions on publicity will be applicable on both i.e. Central Government as well as the State Government.
  - (iv) The relevant provisions of Model Code of Conduct issued by the Election Commission shall be strictly followed


