I am directed to convey the sanction of the President of India for release of an amount of **Rs. 4,38,97,983/- Rupees Four Crore Thirty Eight Lakh Ninety Seven Thousand Nine Hundred and Eighty Three Only** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of Rajasthan 3rd Installment of 1st tranche out of the sanctioned amount of **Rs.208,64,52,994/- (Rupees Two Hundred Eight Crore Sixty Four Lakh Fifty Two Thousand Nine Hundred and Ninety Four Only)** vide Mother sanction order No J-12015/01/2024-RE-IV Sl. No. 78 dated 16.07.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.


2. PAO has reported **Rs. 8,04,03,310/-** as refunded amount due to the failed transactions during 1st May, 2024 to 31st May, 2024. This amount has also been included in the current Mother Sanction order for utilizing the fund. The residual amount of **Rs. 333,93,04,789/- (SC: Rs. 137,28,81,846/-), (ST: Rs. 17,33,474/) and (OTH: Rs.196,46,89,469/)** vide mother sanction order of even no. dated 03.06.2024 (U.O. No. 130/Finance/2024-25, dated 31.05.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is **Rs.208,64,52,994/- (NeFMS amount) + Rs. 8,04,03,310/- (re-initiated amount) + Rs. 333,93,04,789/- (residual amount of previous mother sanction) i.e total Rs. 550,61,61,093/-**

5. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.
6. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.
7. All other terms and conditions mentioned in mother sanction order No. J-12015/01/2024-RE-IV Sl. No. 78 dated 16.07.2024 shall remain the same.
8. No Utilization Certificate is pending against the Recipient Organization under the Scheme.
9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 236 (1) of the General Financial Rules, 2017.
10. The Drawing and Disbursing Officer, Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para -1 above will be transferred to State Employment Guarantee Fund in Account No. 61310683569 in the name of State Employment Guarantee Fund Jaipur, in the State Bank of India (SBI), Branch SBI Secretariat Jaipur, IFSC Code: SBIN0031031.


