- 9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 236 (1) of the General Financial Rules, 2017.

- 11. This issues under the powers delegated to this Ministry and in consultation with the Integrated Finance Division vide their U.O No. 407/Finance/2024-25, dated 29.08.2024.
 - 13. Keeping in view the imposition of model code of conduct in the light of General Election to Legislative Assembly of UT of Jammu & Kashmir, 2024, the sanction is subject to following conditions:
 - i. Absolutely no publicity in this regard shall be made in electronic, print, radio and internet or any other media, in any from whatsoever.

 - iii. These restrictions on publicity will be applicable on both i.e. Central Government as well as the State Government.
 - iv. The relevant provisions of Model Code of Conduct issued by the Election Commission shall be strictly followed.
