- 11. This issues under the powers delegated to this Ministry and in consultation with the Integrated Finance Division vide their U.O No. 407/Finance/2024-25, dated 29.08.2024.
- 12. Keeping in view the imposition of model code of conduct in the light of General Election to Legislative Assembly of UT of Jammu & Kashmir, 2024, the sanction is subject to following conditions:
- i. Absolutely no publicity in this regard shall be made in electronic, print, radio and internet or any other media, in any from whatsoever.

- iii. These restrictions on publicity will be applicable on both i.e. Central Government as well as the State Government.
