Subject:-Mahatma Gandhi National Rural Employment Guarantee Act (Mahatma Gandhi NREGA): Payment of 2nd Installment of 2nd tranche of Central Assistance towards wage payment for Financial Year 2024-25 to the Union Territory of Jammu & Kashmir.

Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs. 7,98,50,199/- (Rupees Seven Crore Ninety Eight Lakh Fifty Thousand One Hundred and Ninety Nine Only)** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of UT of Jammu & Kashmir as 2nd Installment of 2nd tranche out of the sanctioned amount of **Rs. 203,37,51,894/- (Rupees Two Hundred and Three Crore Thirty Seven Lakh Fifty One Thousand Eight Hundred and Ninety Four Only)** vide Mother sanction order No. J-12016/01/2024-RE-IV SI.No.149 dated 27.11.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.


2. PAO has reported Rs. 3,34,38,067/- as refunded amount due to the failed transactions during 1st June, 2024 to 31st October, 2024. This amount has also been included in the current Mother Sanction order for utilizing the fund. The residual amount of **Rs. 36,40,92,068/- [(SC: Rs. 6,20,95,167/-), (ST: Rs. 27,39,50,544/-) and (OTH: Rs. 2,80,46,357/-)]** vide mother sanction order of even no. dated 29.08.2024 (U.O.No.407/Finance/2024-25, dated 29.08.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the UT for wages is **Rs. 203,37,51,894/- (NeFMS amount) + 3,34,38,067/- (Re-initiated amount) + Rs. 36,40,92,068/- (Residual amount of previous mother sanction) i.e total Rs. 243,12,82,029/-**

3. The total amount available for release to the State for wages is **Rs. 148,85,24,108/-** is as under:-

The payment under DBT are linked to the FTOs generated based on primary records retained at GP/Block level and therefore the accounts/primary records will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development in terms of Rule 236(1) of the General Financial Rules 2017.
5. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.
6. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.
7. All other terms and conditions mentioned in Mother Sanction order No.J-12016/01/2024-RE-IV Sl.No.149 dated 27.11.2024 shall remain the same.
8. No Utilization Certificate is pending against the Recipient Organization under the Scheme.
9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of **Rule 236 (1) of the General Financial Rules, 2017**.
10. The Drawing and Disbursing Officer, Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para -1 above will be transferred to UT Employment Guarantee Fund in **Account No. 0110040510000001 in the name of NeFMS Wage Payments MGNREGA in the Jammu and Kashmir Bank Ltd., Branch Moving Secretariat Srinagar, IFSC Code: JAKA0MOVING.**
11. This issues under the powers delegated to this Ministry and in consultation with the Integrated Finance Division vide their **U.O No. 758 Finance/2024-25, dated 27.11.2024**


