I am directed to convey the sanction of the President of India for release of an amount of Rs. 5,90,23,036/- (Rupees Five Crore Ninety Lakh Twenty Three Thousand and Thirty Six Only) to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of UT of Jammu & Kashmir as 2<sup>nd</sup> Installment of 2<sup>nd</sup> tranche out of the sanctioned amount of Rs. 203,37,51,894/- (Rupees Two Hundred and Three Crore Thirty Seven Lakh Fifty One Thousand Eight Hundred and Ninety Four Only) vide Mother sanction order No. J-12016/01/2024-RE-IV SI.No.149 dated 27.11.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

- 2. PAO has reported Rs. 3,34,38,067/- as refunded amount due to the failed transactions during 1st June, 2024 to 31st October, 2024. This amount has also been included in the current Mother Sanction order for utilizing the fund. The residual amount of Rs. 36,40,92,068/-[( SC: Rs. 6,20,95,167/- ), ( ST: Rs. 27,39,50,544/- ) and ( OTH: Rs. 2,80,46,357/-) ] vide mother sanction order of even no. dated 29.08.2024 (U.O.No.407/Finance/2024-25, dated 29.08.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the UT for wages is Rs. 203,37,51,894/-(NeFMS amount) + 3,34,38,067/- (Re-initiated amount) + Rs. 36,40,92,068/- (Residual amount of previous mother sanction) i.e total Rs. 243,12,82,029/-
- 3. The total amount available for release to the State for wages is Rs. 105,62,64,484/- is as under:-

- 8. No Utilization Certificate is pending against the Recipient Organization under the Scheme.
- 9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 236 (1) of the General Financial Rules, 2017.
