Hence, the total amount available for release to the UT for wages is Rs. 203,37,51,894/-(NeFMS amount) + 3,34,38,067/- (Re-initiated amount) + Rs. 36,40,92,068/- (Residual amount of previous mother sanction) i.e total Rs. 243,12,82,029/-
