Hence, the total amount available for release to the UT for wages is Rs. 76,21,97,000/- (NeFMS amount) + Rs. 6,47,67,683/- (re-initiated amount) + Rs. 37,78,55,309/- (residual amount of previous mother sanction) i.e total Rs.120,48,19,992/-
