I am directed to convey the sanction of the President of India for release of an amount of Rs. 2,07,35,936/-(Rupees Two Crore Seven Lakh Thirty Five Thousand Nine Hundred and Thirty Six Only) to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of UT of Jammu & Kashmir as 1st Installment of 1st tranche out of the sanctioned amount of Rs. 314,21,27,000/- (Rupees Three Hundred Fourteen Crore Twenty One Lakh Twenty Seven Thousand Only) vide Mother sanction order No. J-12016/01/2024-RE-IV SI.No.9 dated 06.04.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

- PAO has reported Rs. 6,47,67,683/- as refunded amount due to the failed transactions during 1<sup>st</sup> April to 31<sup>st</sup> May 2024. This amount has also been included in the current mother sanction for utilizing the fund. Hence, the total amount available for release to the UT for wages is Rs. 76,21,97,000/- (NeFMS amount) + Rs. 6,47,67,683/- (re-initiated amount) + Rs. 37,78,55,309/- (residual amount of previous mother sanction) i.e total Rs.120,48,19,992/-
