- PAO has reported Rs. 6,47,67,683/- as refunded amount due to the failed transactions during 1st April to 31 May 2024. This amount has also been included in the current mother sanction for utilizing the fund. The residual amount of Rs. 37,78,55,309/-[(SC: Rs. 23,801/-), (ST: Rs. 2,21,22,504/-) and (OTH:Rs. 35,57,09,004/-)] vide mother sanction order of even no. dated 06.04.2024 (U.O.No.11/Finance/2024-25, dated 05.04.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the UT for wages is Rs. 76,21,97,000/- (NeFMS amount) + Rs. 6,47,67,683/- (re-initiated amount) + Rs. 37,78,55,309/- (residual amount of previous mother sanction) i.e total Rs.120,48,19,992/-
