I am directed to convey the sanction of the President of India for release of an amount of Rs. 5,02,52,966/- (Rupees Five Crore Two Lakh Fifty Two Thousand Nine Hundred and Sixty Six Only) to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of UT of Jammu & Kashmir as 4<sup>th</sup> Installment of 1<sup>st</sup> tranche out of the sanctioned amount of Rs.38,10,00,000/- (Rupees Thirty Eight Crore Ten Lakh Only) vide Mother sanction order No. J-12016/01/2024-RE-IV Sl.No.93 dated 30.07.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

2. The residual amount of Rs. 61,12,33,812/- [(SC: Rs.1,38,190/-), (ST: Rs.7,87,62,580/-) and (OTH:Rs.53,23,33,042/-)] vide mother sanction order of even no. dated 16.07.2024 (U.O.No.245/Finance/2024-25, dated 12.07.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the UT for wages is Rs. 38,10,00,000/- (NeFMS amount) + Rs. 61,12,33,812/- (residual amount of previous mother sanction) i.e total Rs. 99,22,33,812/-

7. All other terms and conditions mentioned in Mother Sanction order No.J-12016/01/2024-RE-IV SI.No.93 dated 30.07.2024 shall remain the same.
8. No Utilization Certificate is pending against the Recipient Organization under the Scheme.
9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of **Rule 236 (1) of the General Financial Rules, 2017.**
10. The Drawing and Disbursing Officer, Mahatma Gandhi NREGA, New Delhi (207172) will be the Drawing & Disbursing Officer for the purpose.
