I am directed to convey the sanction of the President of India for release of an amount of **Rs.4,85,12,007/- (Rupees Four Crore Eighty Five Lakh Twelve Thousand and Seven Only)** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of State of Kerala as 1st Installment out of the sanctioned amount of **Rs.893,59,98,000/- (Rupees Eight Hundred Ninety Three Crore Fifty Nine Lakh and Ninety Eight Thousand Only)** vide Mother sanction order No.**J-12020/01/2024/RE-VIII(387758)/Sl.No.12**, dated **06/04/2024** for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

4. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.
5. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.
6. All other terms and conditions mentioned in Mother Sanction order No.J-12020/01/2024/RE-VIII (387758)/SLNo.12,dated 06/04/2024 shall remain the same.
7. The DDO, MGNREGA, New Delhi (207172), Ministry of Rural Development will be the Drawing & Disbursing Officer for the purpose.


