I am directed to convey the sanction of the President of India for release of an amount of Rs. 15,13,596/- (Rupees Fifteen Lakh Thirteen Thousand Five Hundred and Ninety Six Only) to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of UT of Ladakh as 2nd Installment of 1st tranche out of the sanctioned amount of Rs. 13,24,188/- (Rupees Thirteen Lakh Twenty Four Thousand One Hundred and Eighty Eight Only) vide Mother sanction order No. J-12026/01/2023-RE-IV Sl. No.69 dated 16.07.2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-25.

2. The residual amount of Rs. 11,23,67,537/-[(SC: Rs. 0/-), (ST: Rs. 11,23,61,825/-) and (OTH: Rs. 5,712/-)] vide mother sanction order of even no. dated 06.04.2024 (U.O. No. 15/Finance/2024-25, dated 05.04.2024) has been carried forward into the current Mother Sanction for the purpose of utilizing the funds. Hence, the total amount available for release to the State for wages is Rs. 13,24,188/-(NeFMS amount) + Rs. 11,23,67,537/-(residual amount of previous mother sanction) i.e total Rs. 11,36,91,725/-

7. All other terms and conditions mentioned in Mother Sanction order No.J-12026/01/2024-RE-IV SI.No.69 dated 16.07.2024 shall remain the same.
