6. All other terms and conditions mentioned in Mother Sanction order No.J-12034/01/2024/RE-VIII (387759)/Sl.No.105, dated 22.08.2024, shall remain the same.
7. The DDO, MGNREGA, New Delhi (207172), Ministry of Rural Development will be the Drawing & Disbursing Officer for the purpose.
