6. All other terms and conditions mentioned in Mother Sanction order No.J-12034/01/2024/RE-VIII(387759)/SI.No.20,dated 06-04-2024,shall remain the same.
7. The DDO, MGNREGA, New Delhi (207172), Ministry of Rural Development will be the Drawing & Disbursing Officer for the purpose.
