6. All other terms and conditions mentioned in Mother Sanction order No.**J-12042/01/2024/RE-VIII (387786)/Sl.No.130**, dated **21/10/2024** shall remain the same.
7. The DDO, MGNREGA, New Delhi (207172), Ministry of Rural Development will be the Drawing & Disbursing Officer for the purpose.


