**Sub:- Mahatma Gandhi National Rural Employment Guarantee Act (Mahatma Gandhi NREGA) : Payment of 1<sup>st</sup> Installment of 2<sup>nd</sup> tranche of Central Assistance towards wage payment for Financial Year 2024-25 to the State Government Punjab.**

Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs.3,92,72,730/- (Rupees Three Crore Ninety Two Lakh Seventy Two Thousand Seven Hundred and Thirty Only)** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of State of Punjab as 120<sup>th</sup> Installment out of the sanctioned amount of **Rs.469,52,64,000/- (Rupees Four Hundred Sixty Nine Crore Fifty Two Lakh Sixty Four Thousand Only)** vide Mother sanction order No. J-14028/01/2024-RE-I (387874) Sl. No. 120 dated 20/09/2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-2025.

2. PAO has reported **Rs.6,48,32,366/-** as refunded amount due to failed transactions during the month of April 2024 to May 2024. The refunded amount will be bifurcated as SC: Rs.0/-, ST: Rs.0/- and OTH: **Rs.6,48,32,366/-** The residual amount of **Rs.44,77,71,676/-** [(SC: **Rs.27,49,17,126/-**),(ST: **Rs.2,113/-**) & (Others: **Rs.17,28,52,437/-**)] vide Mother Sanction Order of even No. Dated 29.08.2024 (U.O. No. 397/Finance/2024-25) has been carried forward into the current Mother Sanction Order for the purpose of utilizing the funds. Hence the total amount available for release to the State for wages **Rs.520,78,68,042/-** [i.e. **Rs.469,52,64,000/-** (current Mother Sanction) + **Rs.44,77,71,676/-**(Residual amount of previous mother Sanction) + **Rs.6,48,32,366/-** (re-initiated amount of failed transactions).

3. The total amount of **Rs.178,86,84,539/-** is distributed among different categories of beneficiaries




