

**Sub:- Mahatma Gandhi National Rural Employment Guarantee Act (Mahatma Gandhi NREGA) : Payment of 1<sup>st</sup> Installment of 2<sup>nd</sup> tranche of Central Assistance towards wage payment for Financial Year 2024-25 to the State Government Punjab.**

Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs.1,86,79,670/- (Rupees One Crore Eighty Six Lakh Seventy Nine Thousand Six Hundred and Seventy Only)** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of State of Punjab as 121<sup>st</sup> Installment out of the sanctioned amount of **Rs.469,52,64,000/- (Rupees Four Hundred Sixty Nine Crore Fifty Two Lakh Sixty Four Thousand Only)** vide Mother sanction order No. J-14028/01/2024-RE-I (387874) Sl. No. 120 dated 20/09/2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-2025.

2. PAO has reported **Rs.6,48,32,366/-** as refunded amount due to failed transactions during the month of April 2024 to May 2024. The refunded amount will be bifurcated as SC: Rs.0/-, ST: Rs.0/- and OTH: **Rs.6,48,32,366/-** The residual amount of **Rs.44,77,71,676/-** [(SC: **Rs.27,49,17,126/-**),(ST: **Rs.2,113/-**) & (Others: **Rs.17,28,52,437/-**)] vide Mother Sanction Order of even No. Dated 29.08.2024 (U.O. No. 397/Finance/2024-25) has been carried forward into the current Mother Sanction Order for the purpose of utilizing the funds. Hence the total amount available for release to the State for wages **Rs.520,78,68,042/-** [i.e. **Rs.469,52,64,000/-** (current Mother Sanction) + **Rs.44,77,71,676/-**(Residual amount of previous mother Sanction) + **Rs.6,48,32,366/-** (re-initiated amount of failed transactions).

3. The total amount of **Rs.173,07,32,139/-** is distributed among different categories of beneficiaries

The payment under DBT are linked to the FTOs generated based on primary records retained at GP/Block level and therefore the accounts/primary records will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development in terms of Rule 236(1) of the General Financial Rules 2017.

5. Further installment of the remaining sanctioned amount would be released as per FTOs entered in MIS by State Government and reflected in PFMS.

6. The grant in towards plan expenditure and will be utilized for approved items of works subject to the conditions laid down in the Mahatma Gandhi NREGA Guidelines Issued from time to time. No deviation from the provisions of these Guidelines is permissible.

7. All other terms and conditions mentioned in Mother Sanction Order No J-14028/01/2024-RE-I (387874) Sl. No.120 of even number dated 20.09.2024 shall remain the same.

8. The DDO, MGNREGA, New Delhi (207172), Ministry of Rural Development will be the Drawing & Disbursing Officer for the purpose.

9. The amount mentioned in Para -1 above will be transferred to State Employment Guarantee Fund in **Account No.65251791693 in the State Bank of India, Branch- Mohali S. A. S. Nagar, Branch Code No.050502 and Branch IFSC-SBIN0050502.**

10. This issue under the powers delegated to this Ministry and in consultation with the Integrated Finance Division vide their U.O. No. 504/Finance/2024-25 dated 20.09.2024.
