The refunded amount will be bifurcated as SC: Rs.0/-, ST: Rs.0/- and OTH: Rs.6,48,32,366/- The residual amount of Rs.44,77,71,676/- [(SC: Rs.27,49,17,126/-),(ST: Rs.2,113/-) & (Others: Rs.17,28,52,437/-)] vide Mother Sanction Order of even No. Dated 29.08.2024 (U.O. No. 397/Finance/2024-25) has been carried forward into the current Mother Sanction Order for the purpose of utilizing the funds. Hence the total amount available for release to the State for wages Rs.520,78,68,042/- [i.e. Rs.469,52,64,000/- (current Mother Sanction) + Rs.44,77,71,676/-(Residual amount of previous mother Sanction) + Rs.6,48,32,366/- (re-initiated amount of failed transactions.
- 3. The total amount of Rs.373,51,86,72/- is distributed among different categories of beneficiaries
