 I am directed to convey the sanction of the President of India for release of an amount of **Rs.3,25,71,375/- (Rupees Three Crore Twenty Five Lakh Severy One Thousand Three Hundred and Seventy Five Only)** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of State of Punjab as 62nd Installment out of the sanctioned amount of **Rs.469,52,64,000/- (Rupees Four Hundred Sixty Nine Crore Fifty Two Lakh Sixty Four Thousand Only)** vide Mother sanction order No. J-14028/01/2024-RE-I (387874) Sl. No. 120 dated 20/09/2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-2025.


2. PAO has reported Rs.6,48,32,366/- as refunded amount due to failed transactions during the month of April 2024 to May 2024. The refunded amount will be bifurcated as SC: Rs.0/-, ST: Rs.0/- and OTH: Rs.6,48,32,366/- The residual amount of Rs.44,77,71,676/- [(SC: Rs.27,49,17,126/-),(ST: Rs.2,113/-) & (Others: Rs.17,28,52,437/-)] vide Mother Sanction Order of even No. Dated 29.08.2024 (U.O. No. 397/Finance/2024-25) has been carried forward into the current Mother Sanction Order for the purpose of utilizing the funds. Hence the total amount available for release to the State for wages Rs.520,78,68,042/- [i.e. Rs.469,52,64,000/- (current Mother Sanction) + Rs.44,77,71,676/-(Residual amount of previous mother Sanction) + Rs.6,48,32,366/- (re-initiated amount of failed transactions).

3. The total amount of Rs.367,49,70,189/- is distributed among different categories of beneficiaries
