No. 397/Finance/2024-25) has been carried forward into the current Mother Sanction Order for the purpose of utilizing the funds. Hence the total amount available for release to the State for wages Rs.520,78,68,042/- [i.e. Rs.469,52,64,000/- (current Mother Sanction) + Rs.44,77,71,676/-(Residual amount of previous mother Sanction) + Rs.6,48,32,366/- (re-initiated amount of failed transactions.
- 3. The total amount of Rs.341,48,73,862/- is distributed among different categories of beneficiaries
