I am directed to convey the sanction of the President of India for release of an amount of **Rs.9,55,87,259/- (Rupees Nine Crore Fifty Five Lakh Eighty Seven Thousand Two Hundred and Fifty Nine Only)** to the State Employment Guarantee Fund-National Electronic Funds Management (SEGF-NeFMS) Account of State of Punjab as 99th Installment out of the sanctioned amount of **Rs.469,52,64,000/- (Rupees Four Hundred Sixty Nine Crore Fifty Two Lakh Sixty Four Thousand Only)** vide Mother sanction order No. J-14028/01/2024-RE-I (387874) Sl. No. 120 dated 20/09/2024 for implementation of the Mahatma Gandhi NREGA during the financial year 2024-2025.


2. PAO has reported Rs.6,48,32,366/- as refunded amount due to failed transactions during the month of April 2024 to May 2024. The refunded amount will be bifurcated as SC: Rs.0/-, ST: Rs.0/- and OTH: Rs.6,48,32,366/- The residual amount of Rs.44,77,71,676/- [(SC: Rs.27,49,17,126/-),(ST: Rs.2,113/-) & (Others: Rs.17,28,52,437/-)] vide Mother Sanction Order of even No. Dated 29.08.2024 (U.O. No. 397/Finance/2024-25) has been carried forward into the current Mother Sanction Order for the purpose of utilizing the funds. Hence the total amount available for release to the State for wages Rs.520,78,68,042/- [i.e. Rs.469,52,64,000/- (current Mother Sanction) + Rs.44,77,71,676/-(Residual amount of previous mother Sanction) + Rs.6,48,32,366/- (re-initiated amount of failed transactions).

3. The total amount of Rs.258,53,24,825/- is distributed among different categories of beneficiaries

7. All other terms and conditions mentioned in Mother Sanction Order No J-14028/01/2024-RE-I (387874) Sl. No.120 of even number dated 20.09.2024 shall remain the same.
8. The DDO, MGNREGA, New Delhi (207172), Ministry of Rural Development will be the Drawing & Disbursing Officer for the purpose.
9. The amount mentioned in Para -1 above will be transferred to State Employment Guarantee Fund in **Account No.65251791693 in the State Bank of India, Branch- Mohali S. A. S. Nagar, Branch Code No.050502 and Branch IFSC-SBIN0050502.**
