- 9. The amount mentioned in Para -1 above will be transferred to State Employment Guarantee Fund in Account No.65251791693 in the State Bank of India, Branch- Mohali S. A. S. Nagar, Branch Code No.050502 and Branch IFSC-SBIN0050502.
