- 9. The amount mentioned in Para –1 above will be transferred to State Employment Guarantee Fund in Account No.35638070871 in the State Bank of India, Branch- Jawahar Bhavan, Lucknow, Branch Code No.006144 and Branch IFSC- SBIN0006144.
